CHAPTER 1

1.1. INTRODUCTION

The functions pertaining to Mining Sector have been held under a number of Ministries in the past. Before March 2020, the functions were under the Ministry of Natural Resources, Energy and Mining (MNREM). From March 2020, the functions were performed under the Ministry of Natural Resources and Mining (MNRM). In July 2020, the functions were curved out and a fully-fledged Ministry of Mining (MoM) was established after realising the importance of the sector in the quest to restructure the economy, protect the environment, and promote sustainable principles of mining and social wellbeing of the people of Malawi.

The Government of Malawi (GoM) has prioritised mining as one of the economic growth sectors considering that Malawi has predominantly depended on agriculture focusing on tobacco, tea, coffee, maize and a few legumes. As part of restructuring its economy with a view to creating wealth, the mining sector has been identified as one sector worth diversifying into in order to achieve the Malawi Vision 2063. In view of the foregoing, the Ministry of Mining has developed this Strategic Plan to enable it create a clear and desired direction for the future state of the institution following Government re-organization of ministries and departments. The Strategic Plan for 2022-2027 sets out the strategic objectives, expected outcomes, outputs and specific strategies which the MoM intends to achieve over the next five years.

1.2. STRATEGIC OVERVIEW

The Ministry of Mining was established in 2020 to ensure the sustainable development and utilization of mineral and Petroleum resources for the socio-economic growth and development of Malawi.

This mandate is derived from the laws of Malawi and other legal instruments which include the following: Mines and Mineral Act (No 8 of 2019) and Petroleum (Exploration and Production) Act (1983).

1.2.1. Governance and Management Structure

The MoM is headed by the Principal Secretary (PS) who is responsible for providing strategic leadership and support to the operations of the Ministry. The PS reports to the Secretary to the President and Cabinet for any major policy decisions that may be made, while the

Minister provides political leadership. The Principal Secretary performs duties with the support of two directorates which are:

- (i) Department of Mines, which is responsible for promotion of sustainable development and exploitation of mineral and petroleum resources in the country; and
- (ii) Department of Geological Survey, which has the statutory role of generating and providing relevant and up-to-date geoscientific data necessary for economic development of the country. Essentially, the Department is mandated to collect, assess, disseminate and archive all geo-scientific data related to geology, geohazards and mineral resources of the country.

1.2.2. Mandate, Vision, Mission and Strategic Objectives

The MoM has the mandate, vision, mission, goals and strategies as highlighted below which will drive the economy to the desired level.

1.2.2.1. Mandate

The Ministry is mandated to ensure the sustainable development and utilization of minerals and petroleum resources for socioeconomic growth and development of the country.

1.2.2.2. Vision

A nation that sustainably utilizes and manages the mineral and Petroleum resources for socioeconomic growth and development.

1.2.2.3. **Mission**

To coordinate, facilitate, and promote participation of all stakeholders in the sustainable development, utilization and management of mineral and Petroleum resources for socioeconomic growth and development.

1.2.2.4. Strategic Objectives

- i. To ensure the sustainable management and utilization of mineral and Petroleum resources;
- To monitor and assess geological hazards for proper planning and instituting possible mitigation measures;
- iii. To strengthen national, regional and international cooperation in mineral resources management and development;

- iv. To accelerate sustainable economic growth through mineral and Petroleum resources exploitation; and
- v. To strengthen institutional capacity.

1.2.2.5. MDA Priority Programs and Agenda

- i. Regulation and facilitation of exploration and sustainable development of minerals and petroleum resources;
- ii. Provision of geological and mining services for sustainable development;
- iii. Improvement of institutional governance structures and sector transparency and accountability; and
- iv. Growth and development of the small-scale based mining industry.

1.2.2.6. Core Values

The Ministry of Mining abides by the GoM code of ethics and the following are the core values:

- i. Patriotism;
- ii. Collective responsibility;
- iii. Professionalism;
- iv. Integrity; and
- v. Commitment

1.2.3. Legislative and Other Mandates

There are a number of legislative and other mandates that inform and guide the operations of public institutions including MoM. These include: The Constitution, legislative frameworks which are enshrined in the specific Acts of Parliament, policies and international and regional obligations.

Drawing from the various legal instruments that created departments that are under the Ministry, MoM's mandate is to ensure sustainable development, management and utilization of mineral and petroleum resources for the socio-economic growth and development of Malawi.

1.2.3.1. Constitutional Mandate

Section 93, Sub-section 1-3 of the Constitution of Malawi provides for the creation of government departments to be headed by Principal Secretaries. Hence, all the departments under the Ministry are legal entities as mandated by the Constitution.



1.2.3.2. Legislative Mandates

There are a number of Acts of Parliament from which the Ministry of Mining derives its powers to perform the functions contained therein. The key Acts include the following:

- Mines and Mineral Act (2019);
- Petroleum (Exploration and Production) Act (1983);
- Explosives Act (1968);
- Occupational Safety Health and Welfare Act (1997);
- Public Health Act (1948);
- The Environment Management Act (No.19 of 2017);
- Forestry Act;
- National Parks and Wildlife Act; and
- Water Resources Act.

1.2.4. Linkage with other Government Acts

The implementation of the above Acts of Parliament is linked to other broader Government Acts and policies which include:

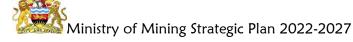
1.2.4.1. The Public Finance Management Act, 2003

The Public Finance Management Act (PFMA) (Cap. 37:02) of 2003 was enacted in order to foster and enhance effective and responsible economic and financial management by Government, including adherence to policy objectives; to provide accountability arrangements and compliance to those arrangements; to obligate Government to produce statements of proposed budget policy, confirmation of adherence to fiscal discipline, economic and fiscal statements, including economic and fiscal forecast and updates, and performance information.

Government considers the PFMA as the basis for transforming public sector institutions to enhance financial prudence and accountability. MoM will therefore ensure that the provisions of the PFMA are adhered to.

1.2.4.2. The Public Procurement and Disposal of Assets Act, 2017

The Public Procurement and Disposal of Assets Act, of 2017 provides general procurement provisions, methods of procurement and their conditions for use, and main principles and



procedures for methods of procurement including their disposal. The Act also provides penalties for no-compliance by controlling officers. MoM and all other institutions in the country are required to comply with these provisions when procuring items for use.

1.2.4.3. The Corrupt Practices Act, 1996

The Corrupt Practices Act, 1996 established the Anti-Corruption Bureau and make comprehensive provision for the prevention of corruption. The functions of the Bureau include investigation and prosecution of corruption matters. Thus, the Bureau takes necessary measures for the prevention of corruption in the public and private sector by among other things:

- Examining the practices and procedures of public and private institutions in order to facilitate the discovery of corrupt practices and secure revision of methods of work or procedures which in the opinion of the Bureau may be prone or conducive to corrupt practices; and
- ii. Advising institutions on ways and means of preventing corrupt practices and on changes in methods of work or procedures.

Corruption, which is commonly defined as abuse of public or private office for private gains is viewed as a major constraint to socio-economic development in Malawi. It is also viewed as a key symptom of weak governance and it has debilitating effects on the economic, social and political environment in which it occurs. Thus, anti-corruption strategies need to be an integral part of a development strategy designed to help the country in eradicating poverty and stimulating socio-economic growth. In light of the above, MoM will ensure that corruption is seriously guarded against in its operations.

1.2.5. The Policy Mandates

MoM is guided by a number of policies in the implementation of its programs and there are also a number of policies that Government has developed to address either broad sectoral and/or specific issues. Some key MoM specific policies include the following:

1.2.5.1. The National Artisanal and Small-Scale Mining Policy

The National Artisanal and Small-Scale Mining Policy was developed in order to adequately administer, regulate and facilitate the growth of ASM Sub-Sector in Malawi. It has been developed based on the potential of the sub sector in contributing towards economic growth and poverty reduction, especially in the rural areas. The role of the State is to facilitate and

regulate the mineral exploration, mining, and mineral processing activities by investors and entrepreneurs, and initiate provision of infrastructure. Malawi Government has therefore, developed this policy in order to guide and regulate the activities of ASM operations. The Policy document also provides direction on appropriate frameworks for investment in the subsector, particularly the nature of investments in mining, the enhancement of institutional, administrative and operational capacity and governance issues in this field.

1.2.5.2. Mines and Minerals Policy

The policy goal is to enhance the contribution of mineral resources to the economy so that it moves from being agro-based to mineral-based economy. The policy is expected to stimulate and guide private mining investment by administering, regulating and facilitating the growth of the sector through a well-organised and efficient institutional framework.

1.2.5.3. National Trade Policy

The policy conveys the Government of Malawi's commitment to make trade a tool for sustainable socio-economic development and poverty reduction. The policy reflects the range of opportunities and challenges facing Malawi and recognises the critical issue of implementation – of both the trade agreements already in place and sectoral policies needed to harness trade for development.

The purpose of the policy is to address weak linkage between trade and overall development objective and binding constraints that have hindered Malawi's ability to take full advantage of existing and emerging market access opportunities. This policy is also necessary to provide direction and enhance domestic policy coherence and coordination.

1.2.5.4. Industry Policy

The National Industrial Policy provides policy direction on how Malawi can develop its productive economy and industrialize. The Government of Malawi recognizes that industrialization and the structural transformation of the economy are essential to maintain rapid long-term economic growth that is needed to raise per capita income, create sufficient rural and urban jobs, widen the tax base to finance Malawi's welfare requirements and address an unsustainable trade deficit. The industrial sector in this context refers to the manufacturing sector of the economy.

The policy goal is an altered GDP growth path resulting from ensuring the industrialization and structural transformation of the Malawian economy by coordinated policy efforts to address key constraints and increase the productive capacity of industry. The focus is on manufacturing.

1.2.5.5. National Export Strategy (NES II)

The NES II is informed and guided by Malawi's frontline National and Sectoral Strategies and Plans, including the perspectives of the new vision, Malawi 2063, MGDS III and more importantly, stakeholders' viewpoints.

The purpose of NES II is to consolidate, expand and diversify exports of goods and services from Malawi in both value and volume terms. The Strategy includes concrete proposals to respond to the needs identified by the stakeholders, in general, and that of the business community, in particular. It identifies products which have strong potential for export growth and markets (regional and international) which present the most promising opportunities. The strategy also identifies and addresses cross-cutting issues, with particular focus on policy, institutional, administrative, and funding preconditions, towards creating an enabling ecosystem conducive for the development and growth of exports from Malawi.

Other Overarching National Strategies and Policies include:

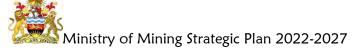
1.2.5.6. Malawi Vision 2063 (MW2063)

The Malawi 2063 (MW2063) expresses our Vision and aspirations as Malawians. It envisions a youth-centric inclusive wealth creating and self-reliant nation by 2063. By 2063, Malawi is principally aspired to be an industrialized upper middle-income country which primarily finances its own development needs. The Vision builds on that of our founding leaders to not only achieve political freedom, but attain economic independence and high quality of life for all.

The MW2063 recognizes mining as a key component of industrialization that will enhance and support local production and export of final products, thus moving away from exporting raw products.

1.2.5.7. Malawi 10 Year Implementation Plan 1 (MIP-1)

The MW2063 First 10-year Implementation Plan (MIP-1) was formulated under a highly consultative process which generated valuable input from various stakeholders, including state and non-state actors.



The Malawi 2063 First 10-year Implementation Plan (MIP-1) operationalizes the MW2063 from 2021 to 2030. This is the first MIP in a series of four 10- year plans that will be developed to drive the implementation and realization of MW2063.

MIP-1 builds on lessons learnt and success from the Malawi Growth and Development Strategy (MGDS) III which was the last operationalization plan of Vision 2020.

1.2.5.8. The Public Service Reforms Policy

The Public Sector Reforms Policy provides and outlines an agenda on public sector reforms, the institutionalization of the reforms as well as the management, monitoring and evaluation of the reforms.

The policy covers issues in the public sector that need to be addressed through reforms and are consequently taken as key priority areas in the reform process that will be pursued in the short to medium term. The PSR Policy is a living document, which will be subject to review every 5 years in tandem with the changes in the medium-term development strategies and global trends in public administration and development generally.

1.2.5.9. The Public Service Management Policy

The Public Service Management Policy provides a framework for the management of the public service to effectively deliver public goods and services and facilitate development in line with the national development agenda. It includes Government's policy commitments that will drive public service and strategies that it will use to improve public service management.

1.2.6. Regional and International Agreements

1.2.6.1. Agenda 2063

Malawi is a signatory to the Agenda 2063, "The Africa We Want" which aims at building upon the achievements and draw lessons from earlier strategic planning efforts at regional and sub-regional level, including the Lagos Plan of Action. The Abuja Treaty and the NEPAD also address new and emerging issues in the continent over the short, medium and long-term period. MoM will ensure that relevant thematic areas of the Agenda 2063 are adequately domesticated.

1.2.6.2. Sustainable Development Goals



The Sustainable Development Goals (SDGs) are a new universal set of goals, targets and indicators that UN member states are expected to use to frame their national development agendas/strategies over the next fifteen (15) years. The SDGs are a comprehensive and ambitious set of goals intended not only to spur growth but also ensure that such growth is equitably shared so as to leave no one behind. They are aimed at creating a just society where resources are sustainably utilized in such a way that the lives and well-being of all citizens are safeguarded.

The effective achievement of the SDGs at national level depends on the country having requisite capacity to domesticate and implement the 17 goals and targets in the relevant sectors of the economy. MoM as an institution will ensure that relevant goals, targets and indicators are identified and mainstreamed in its various programs.

CHAPTER 2

2.1. OVERVIEW OF THE IMPLEMENTATION OF MoM DEPARTMENTAL PROGRAMS BETWEEN 2018 – 2021

The implementation of the respective Departmental programs prior to the split from MNREM attest some achievements, challenges and lessons learnt in the process.

2.2.1. Achievements, Challenges and Lessons Learnt

Some of the notable achievements, challenges and lessons learnt are as outlined in Table 1 below.

CHAPTER 3

3.1. THE STRATEGIC ANALYSIS

The African Mining Vision, SADC Industrialisation Agenda, and the Malawi Vision 2063, MIP-1, National Export Strategy (NES), provide a solid direction which guide the mining sector. The process of developing 2022 – 2027 Strategic Plan involved an assessment of its current internal and external operating environment. The assessment was conducted in order to have an understanding of the Ministry's strengths and weaknesses and for identifying both the opportunities that are open for it to capitalize on, and minimize threats or challenges that it is facing. Strengths, Weaknesses, Opportunities and Threats (SWOT) Analysis Technique as well as the Political, Economic, Social, Technological, Environmental, and Legal (PESTEL) analysis, were therefore used as tools during the examination that was based on the Ministry's Key Result Areas (KRAs).

3.2. KEY RESULT AREAS (KRAS)

The strategic analysis commenced with the identification of the Ministry's Key Result Areas (KRAs) based on its mandate on which the SWOT analysis was conducted. The KRAs that are reflected below are basically the primary responsibilities of MoM that no other institution can perform.

In pursuit of achieving its mandate, the Ministry has identified two Key Result Areas (KRAs) which form the basis for the determination of its strategic direction. These are as follows:

3.2.1 Provision of Geological and Mining Services

Government of Malawi recognizes that the mineral sector has the potential to contribute towards rapid economic growth and development of the country. Currently, the sector is underdeveloped despite having a number of known mineral potential areas.

Against this background, MoM has put in place measures to improve provision of geological and mining services to stimulate investment in the sector. The Ministry has the Mines and Mineral Act (No.8 of 2019), Mines and Mineral Policy (2013), Artisanal and Small-Scale Mining Policy (2018) and National Petroleum (Exploration and Exploitation) policy as instruments for the provision of guidance and direction of the industry. However, the Mines and Mineral Policy (2013) and Artisanal and Small-Scale Mining Policy (2018) are due for review.

As one way of participating in global and regional initiatives that address mineral sector issues, including practice, governance and other emerging realities, MoM subscribes to Extractive Industry Transparency Initiative (EITI). Locally, MoM subscribes to MWEITI whose Secretariat is the Secretary to the Treasury.

It is Government's conviction that if the mineral and petroleum resources are fully exploited, the contribution of mining to the GDP will significantly increase in the next 15 years. As one way of resuscitating rural economies and transforming them into potential drivers of economic growth and development, Government adopted the Integrated Rural Development (IRD) in 2017. This compelled Government to shift its attention by empowering local communities to engage themselves in socio-economic activities and improve quality standards for small and medium enterprises. To that effect, Government approved the Artisanal and Small-Scale Mining Policy with an aim of promoting entrepreneurship, job creation and environmentally sustainable mining practices.

3.2.2. Provision of Corporate Services

The objective of the administration and management services (corporate services) in the institution is to ensure the overall administration and governance of MoM is in line with the applicable laws, regulations, policies, rules, and procedures and shared institutional arrangements. The corporate services work stream is the focal point for all the Ministry's key priority areas.

This Key Result Area provides policy guidance and administrative support services to the Ministry by:

- i. Improving organizational, managerial and administrative services;
- ii. Enhancing management of organizational performance through planning, monitoring and evaluation:
- iii. Strengthening financial processes in accordance with policies and regulatory requirements;
- iv. Provision of oversight on the management of human resources;
- v. Improving information management services; and



vi. Mainstreaming cross-cutting issues (HIV & AIDS, environment, gender, nutrition and disability) in all programs and policies.

3.3. SWOT ANALYSIS

The SWOT Analysis considered the internal factors (strengths and weaknesses) and external factors (opportunities and threats) that have significant impact on the effective delivery of MoM services and its contribution to the nation's socio-economic development agenda. Specifically, the strategic analysis centred on issues that impact on the identified KRAs. The SWOT Analysis for each KRA is set out in **Table 2** below:

CHAPTER 4

4.1. KEY RESULT AREAS, STRATEGIC OUTCOMES AND OUTCOME TARGETS

This section gives a detailed roadmap for the MoM options which will drive the strategic direction of the Ministry towards the realization of the desired results. It highlights MoM Key Result Areas (KRAs) which form the basis for the determination of strategic outcomes and targets as tangible reflections of its Vision which is expected to be achieved by 2027. These strategic outcomes are aligned to the KRAs and constitute the strategic direction that it will take between 2022 and 2027.

The determination of MoM 2022 – 2027 Strategic direction was highly participatory and was informed by the Constitution, the relevant Acts of Parliament that created the Departments comprising the Ministry including the MIP-1 and the MW2063, the Ministry's specific policies and other government sectoral policies. The strategic direction has thus been defined to set the pace for a more focused approach to achieve the MoM intended results. Details of the KRAs, strategic outcomes and outcome targets are shown in **Table 4** below.

CHAPTER 6

6.1. STRATEGIC PLAN IMPLEMENTATION

6.1.1. Critical Success Factors

In determining strategic outcomes and targets, outputs and annual output targets to be achieved, MoM is aware that there are certain critical elements that must be made available for the outcomes to be successfully attained and sustained. These are important assumptions which must be considered, put in place and observed in order to successfully realize the intended results from implementing the Strategic Plan.

Critical Success Factors (CSF) may change overtime, hence the need for MoM to regularly observe them and make necessary adjustments to the set targets in relation to the CSFs depending upon the circumstances. Some CSFs that are assumed to be in place for MoM to achieve the targets reflected in **Table 4** and **Table 5** in Chapter 4 are Strategic Leadership, Human Resource, Financial Resources, Political Environment, and Supportive and Collaborative Stakeholders.

6.1.1.1. Strategic Leadership

Leadership is the driving force for the accomplishment of any organization's goals and objectives. It is therefore imperative that MoM leadership is proactive, visionary, inspiring and accommodative of other people's views and be able to delegate responsibilities. This includes commitment to see the implementation processes through.

6.1.1.2. Human Resource

Human resource is the most critical resource for any organization as it relates to the implementation of all activities through people. MoM leadership shall therefore ensure that adequate professional human resource is recruited, retained and trained to acquire core competencies to enable efficient and effective service delivery.

6.1.1.3. Financial Resources

Almost all the activities of MoM will require financial resources for implementation. It is therefore assumed that MoM will be able to mobilise adequate financial resources to match with the requirements of the planned output targets and the sustainability of its operations in general.

6.1.1.4. Political Environment

It is assumed that the political environment in the country will remain stable for the entire Strategic Plan implementation period and beyond. It is also assumed that the political leadership will support the activities of MoM more especially in enacting and enforcing the mining and supporting policies in the extractive industries.

6.1.1.5. Supportive and Collaborative Stakeholders

It is assumed that MoM will receive adequate support from key stakeholders including development partners, NGOs, CSOs and the entire citizenry.

6.1.2. Risks and Mitigation Measures

There are several risks to the implementation of this Strategic Plan that may affect the realization of planned output targets, strategic outcomes and ultimately its mandate. The matrix below provides a list of possible risks and suggested mitigation measures.

CHAPTER 7

7.1. MONITORING AND EVALUATION

7.1.1. Monitoring

Monitoring implementation of the Strategic Plan will constitute systematic tracking of activities and actions to assess progress. Progress will be measured by the achievement of specific outputs against expected or planned output targets. This will help the Principal Secretary and the Management team to remain alert on any shortfalls or deviations on planned activities and take early corrective action. Effective monitoring will help the Ministry to identify challenges and problem areas, and to take immediate remedial action thereby ensuring that the relevant expected targets are achieved.

7.1.2. Evaluation

Performance evaluation is very important as it entails comparing actual against expected results and the resultant impact. In this fast-changing environment, some of the key assumptions in the Plan may dramatically change and affect implementation of the programs and achievement of the set outcome targets and outputs. It is therefore, in the course of evaluation, that MoM will determine the effect of such changes and ensure that appropriate corrective actions are taken.

7.2. REVIEW OF THE STRATEGIC PLAN

The review of the Strategic Plan will be threefold. Firstly, in terms of checking progress in the implementation and achievement of planned annual output targets. The Plan will be reviewed at the end of each financial year basing on the achievement of the annual output targets which constitute the Annual Work Plans prior to the budget development process to reflect cost estimates for the impending fiscal year. Output targets that have not been achieved in the previous year but are still relevant may be carried forward. Secondly, a midterm review of the Plan will be undertaken in 2024/2025 FY to establish progress made and whether having reached this far, the Ministry is moving in the right direction. The mid-term review may also entail incorporating new developments and emerging issues requiring immediate attention. Finally, a full review of the Plan will be conducted at the end of the implementation period in 2027 when the Plan expires.

7.3. FINANCIAL RESOURCES MOBILIZATION

The successful implementation of this Strategic Plan will depend not only on the quality and commitment of staff, but also largely on the availability and efficient utilization of financial and other resources. The various possible sources of funding include the following:

- i. Funding from the Ministry of Finance (MoF) through the Program Based Budget covering both Recurrent and Development Expenditure;
- ii. Appropriations-In-Aid (AIA) which include application fees for various services provided by the Ministry such as mining fees, royalties and miscellaneous income; and
- iii. Funding provided by development partners.
